**A.** South side Drainage. Muesser has started the project. Most of the time there is only one person working. The Board is not in favor of granting another extension.

### **New Business**

- A, Changing name of Oakley Road. There was a fire and the fire department went to the wrong area. Send out letters to residents affected the most by this to get their input.
  - B. Donation to FHF. No one was at meeting so table for now
- C. Start off Right Donation. This program provided backpacks and school supplies to students in the Cerro Gordo area. Last year the Village donated \$500. Motion by Trustee Seitz to make a donation of \$750 for the backpack program and the infant program to be used for those that reside in CG, second Martin, all yeas.
- D, Rummage Sale Ad donation. Motion by Trustee Seitz to make a \$50 donation, second Gross, all yeas.
- E. Annual Sidewalk replacement Porter Brothers have a bid of .35 per linear foot. Mark has replacements in mind-finish the walk on East Duffee, also do some repairs. He would like input from the Streets and Alleys Committee.
- F. Dash-cam for Squad car. Camera in Pat's squad car has failed and is 10years old. Too costly to repair and a new one with shipping is \$3015.00 Motion to replace camera in squad car made by Trustee Marvin, second Gross, all yeas.

Mark also reports the chlorine alarm monitors are shot-it will cost \$3212 to replace them. Also the large garbage trucks that Advanced Services bring to town are tearing up the roads, especially the corners. The drivers are cutting too close to the sedge.

Seitz. In regards to residents blowing grass out into the streets, he was told when the Village quits throwing rocks in the yard, they will stop throwing grass in the streets.

Allen-would like the Village to send a thank you to Allen Williams and Lynn Clarkson for hiring local youths to walk beans this summer and give them some meaningful employment, also for cleaning up area across the railroad tracks on Jackson Street,
