The regularly scheduled meeting of the Mayor and Board of Trustees for the Village of Cerro Gordo was held on Nov. 19, 2012 at 6:00 in the Municipal Village Hall. The meeting was called to order at 6:00. No public forum was held.

The mayor deviated from the agenda and had the auditor, Kevin Buckley, give his report first.

The fiscal report is finished for the 2011/2012 year. Everything looks good for the audit and paper work is signed to file it with the state and the county.

Consent Agenda

Received the bill from Porter Brothers for the sidewalk work. It will be included in this month's claims. The bill was for \$10,000.00 and will be paid out of MFT. They just have a little clean-up work to do. They did a good job on the walks.

Jeff has started to work weekends.

No further discussion about the consent agenda and a motion to approve was made by Trustee Gross, second Seitz, all yeas.

Water Adjustments

Clerk Ash reported 2 adjustments. One for B. McCarty and one for L. Grider. Both had leaks under the house. Mc Carty's is for \$349.49 and Grider's for \$139.83 Both have signed the adjustment forms and both have had the leaks fixed. Motion to approve made by Trustee Seitz, second Allen, all yeas.

Unfinished Business

- A. Shambaugh water line Ted has signed the agreement. He will handle all fees except the permit which the Village has to obtain. Water rates will be double. Motion to approve agreement made by Trustee Gross, second Seitz, all yeas.
- B. Drainage Change order for TNT.

New Business

- A. Proposed Tax Levy The Board was invited to look at the proposed tax levy. It cannot be passed until we abate the bonds first.
- B. Ord # 583-2012 Setting Public Hearing Date for B.D. for Dec. 17, 2012 Motion to approve this ordinance made by Trustee Ridgeway, second Martin, all yeas.
- C. Dobson Easement This will be a 427 ft easement. Dobson had a couple of issues, one concerned manholes. There will be none on his property, they will be in the ditches. The board has the authority to settle up to a certain amount. Norfleet has agreed to amount for his easement. Motion by Trustee Seitz, second Gross to settle easement for Dobson up to a certain amount. Roll call: Allen, Ridgeway, Seitz, Gross, Martin all yeas, Tirpak, nay.
- D. Change order for drainage project Tom has met with the contractor for this project last week. Still waiting on easement issues. Will need another \$7,000 for high resin tile instead of recycled. There is a potential for failure in 20 years as opposed to 40 years for pipe. Motion to approve change order of approximately \$10,000 made by Trustee Seitz, second Martin, all yeas.
