Minutes for the Village of Cerro Gordo

Nov. 21, 2011

The monthly meeting of the Mayor and Board of Trustees met at 7:00 pm on Nov. 21, 2011 in the Village Hall located at 231 East South Street. Those in attendance are: Mayor Brad Williams, Trustees Tim Allen, Dennis Ridgeway, Mick Tirpak, Dick Seitz, Mike Gross, and Mike Martin. Also present were Atty. Susan Nicholas, P.C. Pat Carter, D.P.W. Mark Blickensderfer, and Clerk Linda Ash.

The meeting was called to order at 7:00. The mayor called for a deviation from the agenda and called for a closed session for personnel, 120/2 C-1. A motion by Trustee Ridgeway, second Tirpak, was made, all yeas. A motion was entered at 7:43 to resume regular session by Trustee Seitz, second Martin, all yeas.

A discussion was held in regards to placing rip-rap around the new pond. Trustee Mike Martin had several people in and they gave some general bids on the cost of doing this project. The contractors all agreed that recycled concrete should not be used because of the possibility of it containing re-bar. Most would get their rip rap from Nokomis. The bids for this project would have very specific bid specs. The potential to hold back final payment on the South East project would help pay for this project. Formal bids call for specs and publication. The board authorizes the engineer to set up bids for pond rip rap.

There are no additions to claims this month. All have been received on time. There were some questions about police leadership training and the importance of the part time officers having this training. A motion to approve the consent agenda was made by Trustee Gross, second Seitz, roll call: Trustees Allen, Ridgeway, Tirpak, Seitz, Gross, and Martin, all yeas.
